WHO MAY APPLY:

Must be a current member of the CT National Guard within the grade(s) of E3 and E5.

**AREA OF CONSIDERATION:** This position is open to the grades of: E3 to E5. Individual selected will receive an AGR Tour with the Connecticut Army. In order to be considered for this position, applicants must meet minimum qualifications as outlined on this announcement.

**INSTRUCTIONS FOR APPLYING:** The documents listed WILL be submitted "AS A MINIMUM". If any of the required documents are not reasonably available to you, a brief letter will be submitted citing the documents missing with a short explanation necessary to certify the Soldier as eligible. Failure to do so may result in a finding of ineligibility and may cause the applicant to lose consideration for this position.

1. Signed original NGB Form 34-1 dtd 20131111 (Application for Active Guard/Reserve Position). Add primary email address in "Current Home Address Line". Application packet will consist of the following documents IAW AR 135-18 and NGR 600-5.
2. Statement of all active service performed. Any of the following documents may be used: NGB Form 23 or 23b(within 12 months of closing date), all DD Form 214s, or DD Form 1506 (Statement of Service).
3. Copy of LAST FIVE (5) NCOERs. If you do not have five NCOERs due to Time in Service (TIS) and Time in Grade (TIG), you must include other documents such as: Letters of Recommendation (LOR), DA 1059's, and/or E4 Evaluations, to make a total of FIVE documents. All LOR's must be signed. If you are missing evaluation periods for reasons other than for TIS/TIG, you must submit a memorandum addressed to the president of board explaining the missing periods. NOTE: This memo does not count as one of the 5 required documents.
4. Security Clearance memorandum from State Security Manager Office dated within 60 days of the closing date of this advertisement. Failure to submit current Certificate of Clearance, will result in being ineligible for consideration.
5. Individual Medical Readiness Record (IMR). PHA date must be within 12 months of closing date & HIV test must be within 24 months from closing date of this advertisement. (Accessible through <https://medpros.mods.army.mil/portal>)
6. CTARNG AGR Soldiers ONLY - Letter of Endorsement (LOE) from BDE AO acknowledging AGR Soldier is applying for another AGR position outside their MSC. AGR Soldiers applying for positions within the same MSC need not submit a LOE.
7. DA Form 705. ACFT or AFT must indicate "GO" (must say "Record" ACFT/AFT on scorecard, and must be dated within 12 months of close date.)
8. Copy of favorable DA 5500 or DA 5501 (Body Content Worksheet) dated w/in 12 months. (If not applicable, upload DA 705 with passing HT/WT or memo/document signed by Training or Readiness stating it does not apply)
9. Individual Medical Readiness Record (IMR). PHA date must be within 12 months of closing date & HIV test must be within 24 months from closing date of this advertisement. (Accessible through <https://medpros.mods.army.mil/portal>)
10. Validated (and current) copy of Selection Board Record Brief (SRB). (Accessible through <https://armgg1.ngb.army.mil/v3/SelfService/CareerCenter/Home.aspx>)

**POSITION COMPATIBILITY REQUIREMENTS:**

The individual(s) must qualify for and be placed in the following compatible MOS/AOC: 74D2

**MINIMUM APPOINTMENT REQUIREMENTS:**

1. POSITION OPEN TO ARMY ONLY - CTARNG.
2. ALL APPLICANTS WILL BE REQUIRED TO SUCCESSFULLY COMPLETE A HAZMAT PHYSICAL AGILITY/DEXTERITY EVALUATION DURING INTERVIEW PROCESS TO INCLUDE WEAR OF HAZMAT PPE INCLUDING SCBA/RESPIRATORY PROTECTION
3. SELECTEE MUST BE ABLE TO RECEIVE ANTHRAX, SMALLPOX, AND OTHER CRE-REQUIRED VACCINATIONS.
4. SELECTEE MUST PASS OSHA PHYSICAL EXAM BEFORE ASSIGNMENT TO THE POSITION
5. Onboard AGR who are in their initial 18 month stabilization period are not eligible to apply, per AR 600-5 para 3-5c. Onboard AGR applicants (who are eligible) must submit an acknowledgment from their AGR supervisor with their packet.
6. Must hold the 74D MOS or meet the below requirements to re-class to MOS 74D within one year; (1) A physical demands rating of Moderate (Gold) (2) A physical profile of 122221. (3)Qualifying scores: A minimum score of 95 in aptitude area ST in ASVAB administered prior to 2 January 2002. A minimum score of 91 in aptitude area ST on ASVAB administered on and after 2 January 2002 and prior to 1 October 2013. A minimum score of 100 in aptitude area ST on ASVAB administered on and after 1 October 2013.
7. The maximum grade for selected individual to start an AGR Tour for this position is E5. E6 and above may apply but must request administrative reduction to E5 prior to starting the AGR tour.. IAW AR 135-18 dated 11 OCT 2019, Table 2-1 rule E.
8. Selectee will incur a three-year service commitment and stabilization of assignment to the 14th CST(WMD) upon completion of the Civil Support Skill Course (CSSC). Applicant must be able to participate in a Hazmat Dexterity Test
9. \*\*Applicants who have voluntarily separated from the AGR Program in lieu of adverse personnel actions, or who have been involuntarily separated from the AGR Program are not eligible to reenter the program.

**BRIEF JOB DESCRIPTION:**

Responsible to perform for the duties of CBRN Team Chief in the event the CBRN Team Chief is not available during a WMD incident. Participates in the state-of-the-art detection and sample collection technology training per the Survey Team training schedule. Expected to be proficient in CBRN antidote administration, safe patient extraction, and crime scene/evidence preservation techniques. Participates in/monitors WMD CST chain of custody (sample transfer) procedures. Follows the national Institute for Occupational Safety and Health (NIOSH) Guide when responding to incidents utilizing the appropriate respiratory protection. Utilizes the established checklist and code words in reporting the detection, identification and sample collection actions in the Hot Zone/contaminated area.
